TEST: BASIC CARDIAC

RESULTS: Normal cardiovascular examination via auscultation - No evidence of congenital or acquired heart disease was noted. Since acquired heart disease may develop later, these evaluation results remain valid for one year, and annual examinations are recommended to continue to monitor cardiac health.

EXCELLENT HIP JOINT CONFORMATION

superior hip joint conformation as compared with other individuals of the same breed and age

BORDERLINE HIP JOINT CONFORMATION

marginal hip joint conformation of indeterminate status with respect to hip dysplasia at this time -- Repeat study in six months

GOOD HIP JOINT CONFORMATION

well formed hip joint conformation as compared with other individuals of the same breed and age

MILD HIP DYSPLASIA

radiographic evidence of minor dysplastic changes of the hip joints

FAIR HIP JOINT CONFORMATION

minor irregularities of the hip joint conformation as compared with other individuals of the same breed and age

MODERATE HIP DYSPLASIA

well defined radiographic evidence of dysplastic changes of the hip joints

SEVERE HIP DYSPLASIA

radiographic evidence of marked dysplastic changes of the hip joints

RADIOGRAPHIC FINDINGS

- subluxation
 remodeling of femoral head/neck
 osteoarthritis/degenerative joint disease
 shallow acetabula
 acetabular rim/edge change

- unilateral pathology left right
 transitional vertebra
 spondylosis
 panosteitis
